Trustee Wallace asked when there would be a fence installed around the dumpster.

Roads Superintendent Tim Parks said that they are waiting for a generator to be installed at the administration building and then a fence would be installed around the dumpster, the tower, and the generator.

Trustee Kretz asked a question about the ability of fire department apparatus to turn around in cul-de-sacs in the Township.

Roads Superintendent Tim Parks replied that after that neighborhood was established, the policy was changed so that cul-de-sacs would be large enough for fire department apparatus would be able to turn around.

TA Zaharieff mentioned that one car parked in the cul-de-sac would inhibit turn around and require additional maneuvering and potentially cause the apparatus to have to back out of the cul-de-sac. The only way to prevent this possible disruption to neighboring homes would be to place no parking signs in the cul-de-sac.

Trustee Kretz requested assistance for some citizens getting a response from the County Engineer about an additional lane on Trebein Road.

TA Zaharieff spoke about offering to speak at Township Homeowner's Association meetings.

Trustee Wallace suggested adding that to the In Touch article.

#### FIRE DEPARTMENT

Administrator Zaharieff presented the bi-weekly report.

Chief VandenBos stated that there have been no patient treatment contracted cases of COVID for our first responders. Vaccines began on 12/31/2020 for Township first responders.

Fiscal Officer Ryan Rushing spoke about going live with Open Checkbook early to mid-February. Residents will be able to go to the fiscal office website to view every check the Township writes. He also noted that pre-numbered motions and resolutions will now appear on the meeting agendas.

<u>20210111-FO-A:</u> A **RESOLUTION** TO REQUEST THE ADVANCE PAYMENTS OF TAX YEAR 2020, COLLECTED CALENDAR YEAR 2021, TAX SETTLEMENTS AND OTHER FUNDS FROM THE GREENE COUNTY AUDITOR.

Trustee Kretz moved to adopt the following resolution:

**WHEREAS**, pursuant to Ohio Revised Code Section 321.34, when a political subdivision requests by resolution the advancement of funds derived from taxes, or other sources that are payable by law to the county treasurer, any money that may be in the county treasury to the accounts of the local subdivision, the county auditor shall pay the township fiscal officer said advancements for the current fiscal year in which the request is made; and

**WHEREAS**, it is necessary that property taxes collected and held by the Greene County Auditor be procured from time to time for the expenditures of the general operating expenses of Beavercreek Township, Greene County, Ohio prior to the regular distributions; and

**WHEREAS**, the Greene County Auditor has and will collect in 2021 those property taxes due for the tax year 2020; and

**WHEREAS**, it is desirable that advances of the 2020 taxes due to Beavercreek Township be advanced to Beavercreek Township prior to the normal settlement dates, in amounts based upon the funds collected by Greene County.

**NOW THEREFORE BE IT RESOLVED THAT**, the Beavercreek Township Board of Trustees, Greene County, Ohio resolve:

**SECTION 1**: The Fiscal Officer is hereby authorized to request and procure from the Greene County Auditor advances from Greene County of any monies due to Beavercreek Township for tax year 2020 property tax collections and other settlements due to Beavercreek Township pursuant to Ohio Revised Code Section 321.34.

**FURTHER BE IT RESOLVED THAT,** the Beavercreek Township Board of Trustees concerning and relating to the adoption of this resolution are being adopted at a duly called and authorized open meeting of the Board of Trustees on the date set forth above, such meeting being duly called pursuant to and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Trustee Dean seconded the motion to adopt the Resolution. Fiscal Officer Rushing called the roll: Trustee Dean, yes; Trustee Kretz, yes; Trustee Wallace, yes. Motion adopted.

#### **TRUSTEES**

Trustee Wallace reported that Miami Valley Regional Planning Commission (MVRPC) meeting was cancelled.

Administrator Zaharieff reported that MVRPC Technical Advisory Committee agenda had no meeting.

Trustee Kretz reported that the Regional Planning and Coordinating Commission of Greene County (RPCC) had a meeting and recommended for approval both the Beavercreek Township zoning map amendments for the I-1 to mixed use PUD and aviation support district.

Trustee Dean reported that the Health Department District Advisory Council met and appreciated the help of Beavercreek Township firefighters with vaccine distribution.

Administrator Zaharieff reported that the School Superintendent, City Manager, and Township Representative committee had no meeting.

Administrator Zaharieff reported that the Wright Patterson AFB Restoration Advisory Board had a meeting and the presentation was shared with the Board. The presentation is available on the Advisory Board website.

Trustee Wallace reported that Greene County Township Association was cancelled.

Trustee Kretz reported that the Investment Oversight Committee has no report.

### **Zoning Commission Case #818 Hearing**

Associate Economic & Zoning Administrator Max McConnell spoke regarding modification of the language for article 19 regarding requirements for permits. If any portion of the improvement fell within an easement, the applicant would need to submit an authorization form from the agency that holds the easement.

Trustee Wallace requested that virtual meetings be held with agencies affected to explain the change.

Associate Economic & Zoning Administrator Max McConnell said that could happen within 30 days if approved by the Board.

Trustee Kretz requested that the word "easement" be changed to "recorded easement" and that wording be included that states that any improvement within a recorded easement may be removed by an easement holder in order to access the easement and the easement holder is not responsible for reimbursement to the property owner for damages resulting from maintenance or other activities within the easement.

Associate Economic & Zoning Administrator Max McConnell said that the former could be changed and the latter could be added to all permits.

Discussion regarding contact information was discussed.

Trustee Wallace opened and closed the public portion of the meeting as there were no citizens there to speak.
